
5. Bids must therefore be delivered to the address below on or before 20 November 2017, 12:00 noon. Late bids shall not be accepted.

**TERMS OF REFERENCE
FOR THE PURCHASE OF EQUIPMENT FOR THE PHILIPPINE EMBASSY IN
MADRID**

1. The list of equipment needed by the Philippine Embassy are the following:
